● **The Central Bank of Libya (CBL), as it publishes this data, affirms the following: -**

1. The statement in its new form, comes within the framework of the CBL's efforts to achieve the highest rates of disclosure and transparency, in response to local and international requests. The CBL continues its efforts to develop this statement in coordination with related institutions.
2. In the context of developing this statement, a special annex includes details of commercial banks' uses of foreign exchange, according to the types of commodities, countries, beneficiary companies. [Click to view](#). This is in addition to the weekly statement publishes by the Central Bank of Libya regarding LCs.
3. During the period, total foreign currency revenues, amounted to 16 billion USD, while total foreign exchange expenditures amounted to approximately 25.8 billion USD.
4. Domestic revenues during August 2023 witnessed a sharp decline; Customs revenues amounted to about 4 million LYD, tax revenues amounted to about 11 million LYD, and local market revenues from oil derivatives reported (zero).
5. Salaries represented 62% of total spending during the period, of which an amount of 15.5 billion LYD, was referred to the financial services controllers in the cities (as shown in the attached table), and represents 41% of the total salaries (Chapter One).
6. The item "Transfers for other PUBLIC entities" included in the table of Foreign Exchange Expenditures with an amount of 522 million USD, represents expenses for public entities, which are: (Libyan Ambulance Service - Executive Authority for Private Aviation - Regulatory authorities - Field Medicine Centre – Participations of the Ministry of Foreign Affairs).
7. The item "LCs for other PUBLIC entities" included in the table of Foreign Exchange Expenditures with an amount of 204 million USD represents expenses for public entities, which are: (Ministry of Health - Ministry of Communications - Transportation Projects Board - The development of administrative centers authority - Executive Authority for Private Aviation - Libyan Passport Authority - Libyan Civil Aviation Authority - Ministry of Interior - Great Man-Made River Project).
8. The fuel import bill has been paid directly by the National Oil Corporation (NOC) since Nov, 2021.
9. In light of implementing the CBL's strategy to provide cash liquidity to all commercial banks' branches, 70 billion LYD has so far been distributed to the branches of commercial banks in all Libyan cities and regions, during the period.
10. The total number of collected cheques processed through the electronic clearing during the period, reached 1,655,208 cheques, with a total value of 44 billion LYD, that were implemented through 648 banks' branches, distributed over the entire country.
11. The total number of active cards reached 2,991,066 cards, while the number of points of sale (POS) reached up to 45,545 devices, and the total trading volume amounted to 5.3 billion LYD.
12. The number of mobile phone e-wallets reached 139,408. The total number of accepted points reached 2397 accepted points. The total trading volume amounted to about 26.5 million LYD.
