• The Central Bank of Libya (CBL), as it publishes this data, affirms the following: -

- 1. The statement in its new form, comes within the framework of the CBL's efforts to achieve the highest rates of disclosure and transparency, in response to local and international requests. The CBL continues its efforts to develop this statement in coordination with related institutions.
- In the context of developing this statement, a special annex includes details of commercial banks' uses of foreign exchange, according to the types of commodities, countries, beneficiary companies. <u>Click to view</u>. This is in addition to the weekly statement publishes by the Central Bank of Libya regarding LCs.
- 3. During the period, total foreign currency revenues, amounted to 22.3 billion USD, while total foreign exchange expenditures amounted to approximately 32.8 billion USD.
- 4. Chapter One expenditure excludes salaries for the month of November, while the total amount spent on financial services controllers in Libyan cities amounted to 22.7 billion LYD, representing about 46% of the total expenditure of Chapter One, and about 57% of the total expenditure.
- 5. The item "Transfers for other PUBLIC entities" included in the table of Foreign Exchange Expenditures with an amount of 560 million USD, represents expenses for public entities, which are: (Libyan Ambulance Service Executive Authority for Private Aviation Regulatory authorities Field Medicine Centre Participations of the Ministry of Foreign Affairs).
- 6. The item "LCs for other PUBLIC entities" included in the table of Foreign Exchange Expenditures with an amount of 273 million USD represents expenses for public entities, which are: (Ministry of Health Ministry of Communications Transportation Projects Board The development of administrative centers authority Executive Authority for Private Aviation Libyan Passport Authority Libyan Civil Aviation Authority Ministry of Interior Great Man-Made River Project Libyan Air Ambulance).
- 7. The fuel import bill has been paid directly by the National Oil Corporation (NOC) since Nov, 2021.
- 8. In light of implementing the CBL's strategy to provide cash liquidity to all commercial banks' branches, 98 billion LYD has so far been distributed to the branches of commercial banks in all Libyan cities and regions, during the period.
- 9. The total number of collected cheques processed through the electronic clearing during the period, reached 2,192,202 cheques, with a total value of 64 billion LYD, that were implemented through 648 banks' branches, distributed over the entire country.
- 10. The total number of active cards reached 3,425,799 cards, while the number of points of sale (POS) reached up to 48,440 devices. While number of card transactions reached up to 46,353,078, and the total trading volume amounted to 9 billion LYD.
- 11. The number of electronic wallets reached 139,781, and the number of acceptance points for electronic wallets reached 2,470, and the number of transactions on portfolios reached up to 451,827, with a total trading volume of about 34 million of LYD.
