#### • The Central Bank of Libya (CBL), as it publishes this data, affirms the following: -

- 1. The statement in its new form, comes within the framework of the CBL's efforts to achieve the highest rates of disclosure and transparency, in response to local and international requests. The CBL continues its efforts to develop this statement in coordination with related institutions.
- In the context of developing this statement, a special annex includes details of commercial banks' uses of foreign exchange, according to the types of commodities, countries, beneficiary companies. <u>Click to view</u>. This is in addition to the weekly statement publishes by the Central Bank of Libya regarding LCs.
- 3. During the period, total foreign currency revenues, amounted to 2.9 billion USD, while total foreign exchange expenditures amounted to approximately 9.9 billion USD.
- 4. The total amounts referred to financial services controllers in cities are 3.9 billion dinars, representing 38% of the total of Chapter One (salaries).
- 5. The total implemented from Chapter III (Development) for 2023 from the Deposit and Trust account reached 3.2 billion Dinars, which was implemented based on the approval of the House of Representatives Finance Committee.
- 6. The fuel import bill has been paid directly by the National Oil Corporation (NOC) since Nov 2021.
- 7. In light of implementing the CBL's strategy to provide cash liquidity to all commercial banks' branches, 9 billion LYD has so far been distributed to the branches of commercial banks in all Libyan cities and regions, during the period.
- 8. The total number of collected cheques processed through the electronic clearing during the period, reached 436,675 cheques, with a total value of 13.2 billion LYD, that were implemented through 660 banks' branches, distributed over the entire country.
- 9. The total number of active cards reached 3,884,391 cards, while the number of points of sale (POS) reached 51,460 devices. While number of card transactions reached up to 15,836,155, and the total trading volume amounted to 2.8 billion LYD.
- 10. The number of electronic wallets reached 140,248, and the number of acceptance points for electronic wallets reached 2,561, and the number of transactions on portfolios reached up to 81,068, with a total trading volume of about 5 million of LYD.
