#### • The Central Bank of Libya (CBL), as it publishes this data, affirms the following: -

- 1. The statement in its new form, comes within the framework of the CBL's efforts to achieve the highest rates of disclosure and transparency, in response to local and international requests. The CBL continues its efforts to develop this statement in coordination with related institutions.
- 2. In the context of developing this statement, a special annex includes details of commercial banks' uses of foreign exchange, according to the types of commodities, countries, beneficiary companies.. <u>Click to view</u> This is in addition to the weekly statement publishes by the Central Bank of Libya regarding LCs.
- 3. During the period, total foreign currency revenues amounted to 4.8 billion USD, while of which \$800 million is royalties total foreign exchange expenditures amounted to approximately 10.5 billion USD.
- 4. According to the decision of the Speaker of the House of Representatives No. (105) of 2023 to form a joint committee of all relevant parties, the committee is still continuing its work to develop a vision for restructuring the unified public budget of the state for the year 2024Chapter One (Salaries) exclude salaries for the month of March, since they were received after 31st of March.
- 5. The total implemented from Chapter III (Development) for 2023 from the Deposit and Trust account reached 7.9 billion Dinars, which was implemented based on the approval of the House of Representatives Finance Committee.
- 6. The fuel import bill has been paid directly by the National Oil Corporation (NOC) since Nov 2021.
- Considering implementing the CBL's strategy to provide cash liquidity to all commercial banks' branches, 16 billion LYD has so far been distributed to the branches of commercial banks in all Libyan cities and regions, during the period.
- 8. The total number of collected cheques processed through the electronic clearing during the period, reached 725,941 cheques, with a total value of 22 billion LYD, that were implemented through 648 banks' branches, distributed over the entire country.
- 9. The total number of active cards reached 3,874,325 cards, while the number of points of sale (POS) reached 53,050 devices. While the number of card transactions reached up to 24,623,526, and the total trading volume amounted to 4.3 billion LYD.
- 10. The number of electronic wallets reached 140,527, and the number of acceptance points for electronic wallets reached 2,640, and the number of transactions on portfolios reached up to 126,586, with a total trading volume of about 77 million LYD.
