• The Central Bank of Libya (CBL), as it publishes this data, affirms the following: -

- The statement in its new form comes within the framework of the CBL's efforts to achieve the highest rates of disclosure and transparency,
 in response to local and international requests. The CBL continues its efforts to develop this statement in coordination with related
 institutions.
- 2. In the context of developing this statement, a special annex includes details of commercial banks' uses of foreign exchange, according to the types of commodities, beneficiary companies, and Countries through which these goods are supplied. Click to view. This is in addition to the weekly statement publishes by the Central Bank of Libya regarding LCs.
- 3. During the period, total foreign currency revenues amounted to \$17.1 billion, of which \$2.5 billion is royalties, while total foreign exchange expenditure amounted to approximately \$23.2 billion.
- 4. The total foreign exchange uses during the period amounted to \$23.2 billion, marking a decrease compared to the \$24.2 billion recorded during the same period in 2023. The foreign exchange deficit during this period is attributed to a decline in foreign exchange revenues, which reached \$17.1 billion, down from \$22.3 billion for the corresponding period in 2023.
- 5. Revenues from the fee imposed on foreign exchange sales amounted to 23.6 billion LYD.
- 6. The local market's revenues from oil derivatives witnessed a sharp decline, as only 61.6 million LYD was received during the period.
- 7. The total implemented from Chapter III (Development) for 2023 from the Deposit and Trust account reached 10.0 billion LYD.
- 8. An amount of \$950 million has been allocated for development projects in the Eastern Province.
- 9. Chapter One (Salaries) excludes November salaries, as it was not received until 30/11/2024.
- 10. The fuel import bill has been paid directly by the National Oil Corporation (NOC) since Nov 2021.
- 11. 59.6 billion LYD has so far been distributed to the branches of commercial banks in all Libyan cities during the period.
- 12. The total number of cheques accepted during the period through the electronic clearing system reached 2,890,587 cheques with a total value of about 96.1 billion LYD implemented through 684 banking branches and clearing centers throughout the Libyan territory.
- 13. The total number of active cards reached 4,754,518, the number of operating POS devices 72,769, the number of transactions 121,653,265, and the total trading volume of 19.9 billion LYD.
- 14. The number of electronic wallets reached 174,149 wallets, the number of acceptance points for wallets 4,726 points, the number of operations on wallets 612,967, and the total trading reached approximately 120.9 million LYD.
- 15. The number of subscribers to banking applications services for the group of banks reached 3,111,952 subscribers, and the total value of financial transactions for banking applications for electronic payment for the group of banks amounted to 84.9 billion LYD.
- 16. The total volume of money traded electronically amounted to 104.9 billion LYD.
