#### • The Central Bank of Libya (CBL), as it publishes this data, affirms the following: -

- 1. The statement in its new form comes within the framework of the CBL's efforts to achieve the highest rates of disclosure and transparency, in response to local and international requests. The CBL continues its efforts to develop this statement in coordination with related institutions.
- 2. In the context of developing this statement, a special annex includes details of commercial banks' uses of foreign exchange, according to the types of commodities, beneficiary companies, and Countries through which these goods are supplied. <u>Click to view</u>. This is in addition to the weekly statement publishes by the Central Bank of Libya regarding LCs.
- 3. Oil revenues deposited into the Central Bank of Libya in February had a relative decline, amounting to \$1.6 billion, compared to approximately \$2 billion in January. As a result, total oil revenues reached around \$3.6 billion, while foreign exchange expenditures during the same period amounted to \$6.1 billion, leading to a foreign exchange usage deficit of \$2.5 billion.
- 4. The fuel import bill has been paid directly by the National Oil Corporation (NOC) since Nov 2021.
- 5. Chapter One (Salaries) excluded February salaries as they were not received during February.
- 6. 16.0 billion LYD has so far been distributed to the branches of commercial banks in all Libyan cities during the period
- 7. The total number of cheques accepted during the period through the electronic clearing system reached 555,054 cheques with a total value of about 24.7 billion LYD implemented through 709 banking branches and clearing centers throughout the Libyan territory.
- 8. The number of POS issued during the period increased to 83,566 POS, compared to the number of POS issued during 2024, which amounted to 76,356 POS, an increase of 7,210 POS
- **9.** The number of active cards reached 4,655,197, while the number of card transactions at ATMs during the period reached 3,065,607, with a total transaction volume of 2.2 billion LYD. Additionally, the number of card transactions at POS reached 24,545,872, with a total transaction volume of 3.8 billion LYD.
- 10. The number of individual subscribers to the instant payment service (OnePay and LyPay) during the period reached 4,071,731, while the number of merchant subscribers reached 47,634. The total number of transactions through the instant payment service was 994,704, with a total transaction value of 6.2 billion LYD.
- **11.** The number of subscribers to banking application services across banks reached 3,301,691. The total number of transactions through electronic applications during the period was 24,187,707, with a total financial transaction value of 60.6 billion LYD.
- **12.** The number of electronic wallets reached 176,661, with 4,578 acceptance points for e-wallets. The total number of transactions through e-wallets during the period was 125,914, with a total transaction volume of 22.6 million LYD.
