• **The Central Bank of Libya (CBL), as it publishes this data, affirms the following: -**

1. The statement in its new form comes within the framework of the CBL's efforts to achieve the highest rates of disclosure and transparency, in response to local and international requests. The CBL continues its efforts to develop this statement in coordination with related institutions.
2. In the context of developing this statement, a special annex includes details of commercial banks' uses of foreign exchange, according to the types of commodities, beneficiary companies, and Countries through which these goods are supplied. [Click to view](#). This is in addition to the weekly statement publishes by the Central Bank of Libya regarding LCs.
3. Foreign exchange usage decreased by 47% in April 2025 compared to March. Foreign exchange usage in April reached \$1.7 billion, of which \$1 billion in letters of credit and \$700 million for personal purposes. Foreign exchange usage in March reached \$3.2 billion, of which \$1.8 billion in letters of credit and \$1.4 billion for personal purposes. The exchange rate remained relatively stable in the parallel market, reflecting the success of the measures taken by the Central Bank of Libya during the period.
4. Oil revenues and royalties transferred to the Central Bank of Libya during the period amounted to \$7,346 million, while foreign exchange expenditures until the end of April 2025 amounted to \$11,871 million, with a deficit of \$4,525 million, the same level as the deficit in March 2025.
5. Revenues from the fees imposed on foreign exchange sales amounted to 8.3 billion LYD.
6. The fuel import bill has been paid directly by the National Oil Corporation (NOC) since Nov 2021.
7. 38.2 billion LYD has so far been distributed through the branches of commercial banks in all Libyan cities during the period.
8. The total number of cheques accepted during the period through the electronic clearing system reached 988,241 cheques with a total value of about 46.7 billion LYD implemented through 711 banking branches and clearing centers throughout the Libyan territory.
9. The number of POS issued during the period increased to 94,271, compared to the number of POS registered in 2024, which amounted to 76,356, an increase of 17,915 POS.
10. The number of active cards reached 4,964,518, while the number of card transactions at ATMs during the period reached 7,856,251, with a total transaction volume of 4.8 billion LYD. Additionally, the number of card transactions at POS reached 53,274,844, with a total transaction volume of 7.7 billion LYD.
11. The number of individual subscribers to the (ONEPAY and LYPAY) instant transfer services during the period reached 4,915,890 subscribers, while the number of merchant subscribers during the same period reached 104,492 subscribers. The number of transactions on the merchant instant transfer service reached 2,104,188 transactions, and the value of financial transactions via the instant transfer service reached 13.4 billion LYD.
12. The number of subscribers to banking application services across banks reached 3,412,447. The total number of transactions through electronic applications during the period was 47,625,924, with a total financial transaction value of 80.5 billion LYD.
13. The number of e-wallets reached 179,886, with 6,026 e-wallet acceptance points. The number of transactions on the wallets during the period reached 237,983, and the total trading volume during the period reached 41.4 million LYD.
