● **The Central Bank of Libya (CBL), as it publishes this data, affirms the following: -**

1. The statement in its new form comes within the framework of the CBL's efforts to achieve the highest rates of disclosure and transparency, in response to local and international requests. The CBL continues its efforts to develop this statement in coordination with related institutions.
2. A special annex will be issued with this statement detailing the uses of foreign currency by commercial banks, according to the beneficiary companies, the classification of goods or services, the country of origin, and the beneficiary country. [Click to view.](#)
3. Oil revenues and royalties transferred to the Central Bank of Libya during the period amounted to \$22.1 billion, while foreign currency uses until the end of December 2025 amounted to \$31.1 billion, with a deficit of approximately \$9.0 billion. The increase in the value of the deficit during the period is due to the decline in oil revenues supplied to the bank since September. This deficit was imbursemented by the returns on the central bank's investments in deposits, bond portfolio and gold, resulting in a surplus of approximately \$1.7 billion.
4. Total public spending excluding fuel items during 2025 amounted to 120.0 billion LYD, compared to 123.2 billion LYD during 2024.
5. The Central Bank of Libya's total foreign assets amounted to \$99.4 billion at the end of December, compared to \$95.5 billion at the end of 2024.
6. Revenues from the fees imposed on foreign exchange sales amounted to 23.2 billion LYD.
7. 98.0 billion LYD has so far been distributed through the branches of commercial banks in all Libyan cities during the period.
8. The number of checks accepted through the electronic clearing system during 2025 amounted to 3,074,595 checks, with a total value of 143.2 billion LYD, compared to an amount of 110.9 billion, implemented through 718 bank branches and clearing centers across the entire Libyan territory.
9. The Point-of-Sales (POS) issued during the period increased to 150,205, compared to the number of POS recorded during 2024, which amounted to 76,356, an increase of 73,849 POS.
10. The number of activated cards reached 5,342,461 cards, and the number of card transactions on ATMs during the period reached 21,126,463 transactions, and the total volume of withdrawals during the period reached 10.9 billion LYD. The number of card transactions on points of sale reached 230,973,651 transactions, with a trading volume value during 2025 amounting to 30.6 billion LYD, compared to 19.2 billion LYD during 2024, an increase of 11 billion LYD.
11. The number of individual subscribers to the LYPAY and ONEPAY instant transfer services reached 6,839,395 during the period, while the number of merchant subscribers reached 171,804 during the same period. The number of transactions on the merchant instant transfer service reached 12,206,303. The value of financial transactions through instant transfer services during 2025 amounted to 74.7 billion LYD, compared to 1.4 billion LYD during 2024, an increase of 73 billion LYD.
12. The number of subscribers to the banking group's application services reached 3,789,212 subscribers, and the total number of transactions on electronic applications during the period reached 153,999,411 transactions, and the value of financial transactions via mobile phone applications during 2025 amounted to 272 billion LYD, compared to 111 billion LYD during 2024, an increase of 161 billion LYD.
13. The number of electronic wallets reached 185,699 wallets, and the number of acceptance points for electronic wallets reached 6,136 acceptance points, and the number of transactions on the wallets during the period reached 605,704 transactions, and the total trading volume during the period reached 85 million LYD.
14. Electronic payment instruments witnessed an unprecedented increase during 2025, as the total amount of transactions reached 389 billion LYD compared to 136 billion LYD during 2024, an increase of 253 billion LYD, or an increase of approximately 186%.
